

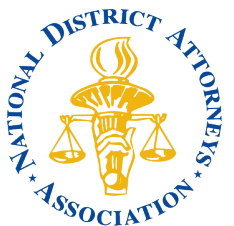

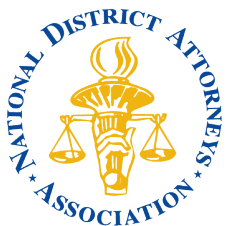

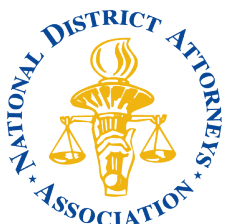

What happens to a Commercial Driver's License?

The National Traffic Law Center (NTLC) has created an education tool for prosecutors, law enforcement and other traffic safety professionals titled: "Human Trafficking and the Impact on Commercial Driver's Licenses." This on demand training module is designed to educate about the Federal "No Human Trafficking on Our Roads Act" (NHTRA) which was signed into law on January 1, 2018 by President Donald J. Trump. As a result of NHTRA, the Federal Motor Carrier Safety Administration (FMCSA) announced a final rule that imposes a lifetime ban on drivers who are convicted of a severe form of human trafficking in a commercial motor vehicle
